The Board of Directors of FRUIT approved the share buyback program of Php100 million on February 3, 2025.

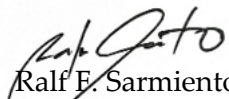
As a result of the buyback made on July 08, 2026, the remaining balance of the amount for the buyback as of this date is Php74,701,040
